### Section 1: Organisation profile

A brief organisation profile is required, and a submission covering the following structure:

### Section 2: Policy and reporting

- Provide organisation's vision, mission, and values in connection with environmental sustainability principles.
- Provide Environmental Policy, which must be signed and dated. Where available, your sustainability policy should also be shared.
- Demonstrate how environmental sustainability management performance is reported.

### Section 3: Corporate environmental sustainability management

- Demonstrate how the environmental sustainability is considered as part of effective business management processes:
  1. Discuss top-management commitment to environmental sustainability
  2. What roles and responsibilities are assigned for environmental sustainability
  3. What indicators or SMART objectives are used to assess and track performance
- Indicate how experience is shared, and training used to promote good management practices in connection with environmental sustainability management
- Detail partnerships and collaboration strategies
- Describe the regime for environmental monitoring and reporting, and provide evidence of its implementation.
- How do you work with your supply chain to adhere to environmental sustainability standards.
- What are you doing to contribute to the United Nations Sustainable Development Goals?  
Note: Here we are looking at your high-level alignment, in next section you can report your practical measures.

### Section 4: Practical initiatives and innovation

A short summary is required on how your organisation contributes in a practical way to each of the following subjects:

- Carbon and greenhouse gas emissions monitoring, and reduction - including energy management
- Implementing the waste hierarchy, notably prevention, reuse and recovery
- Hazardous material minimisation (if appropriate)
- Pollution Minimisation
- Product Development: For Manufacturing or Construction Sectors: Product Development e.g. eco-product / build, environmental labelling. For Utility/Energy/Site/Estate Management: Environmental Impact Assessment and Mitigation
- Biodiversity Action Plans or habitat improvements (direct or supply chain)
- Supply Chain Improvement
- Sustainable Transport / Green Fleet Logistics

For three of these subjects, the narrative must be expanded on in more detail.

### Section 5: Enforcement experience

Provide details of any enforcement action, and how your organisation has responded to it.

## How entries are judged

Assessors help identify a shortlist of the top-scoring entries, using a scoring matrix based on the published criteria to be covered. The shortlist is then reviewed by separate judging panel, environmental professionals appointed by RoSPA.

The resulting award is a single trophy for one overall winner in the category. Additional commendations may be made at the judges' discretion.

The selection of a winner is based in part on quantitative scores relating to how well the entrant has fulfilled the category criteria, but judges will also consider a submission's merits from a qualitative perspective.
