## WHY RoSPA?

## OUR INSPECTIONS

There are British Standards that relate to indoor soft play centres. These Standards and the Health and Safety Executive recommend an independent annual inspection of the facility from an organisation such as RoSPA.

RoSPA inspections are non-dismantling and assess Standard compliance where this may be tested without removal of parts or destruction. A RoSPA Certificate of Inspection can be provided on request.

## AS SAFE AS NECESSARY...

RoSPA believes that places where children play should be as safe as necessary, NOT as safe as possible. Play provision aims to offer children the chance to encounter acceptable risks as part of a stimulating, challenging and controlled learning environment. This is an approach endorsed by the Health & Safety Executive.

## ROSPA INSPECTION INCLUDES

- Inspection of the area for compliance with Standards and other safety issues
- Inspection of play items for compliance with Standards and other safety issues
- Risk Assessments of play areas as required by the Management of Health and Safety at Work Regulations
- Inspection of ancillary areas such as entrance, seating areas etc for safety compliance
- Advice on recommended maximum numbers
- Comments and advice on Management Procedures
- Post Installation Inspections will also focus on the quality of workmanship to ensure that the operator does not get involved in untimely maintenance costs.

## TRAINING COURSES

RoSPA can provide a one day course covering operation, inspection, maintenance and management of Indoor Play Areas. This course can be combined with our Inspections. For details of courses contact us on 01367 244600.

## COSTS OF PLAY AREA INSPECTIONS

Annual Inspection of the play area is £395. This covers inspection of the play frame and any ancillary building areas as well as providing a Risk Assessment.

On-site training on basic regular inspection and management procedures can be provided at an additional cost of £100.

Post Installation Inspections of new play areas are £475, inclusive of a Risk Assessment. This is recommended on ALL new play structures. In order to avoid forgetting to order your annual inspection, place a standing order for your site to be inspected every year until further notice. Written notification of the upcoming inspection will be sent out several weeks in advance in case you wish to alter or cancel any of the arrangements.

## DESIGN REVIEW

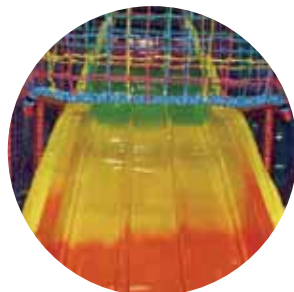
RoSPA can check site plans and provide comments and advice before installation work commences (fee chargeable).
